6. Promote regular attendance, academic improvement, and overall child development.
7. Improve foundational learning levels in core subjects such as Mathematics, Science, English, and regional languages
8. Reduce school dropout rates by ensuring consistent academic support and family engagement.

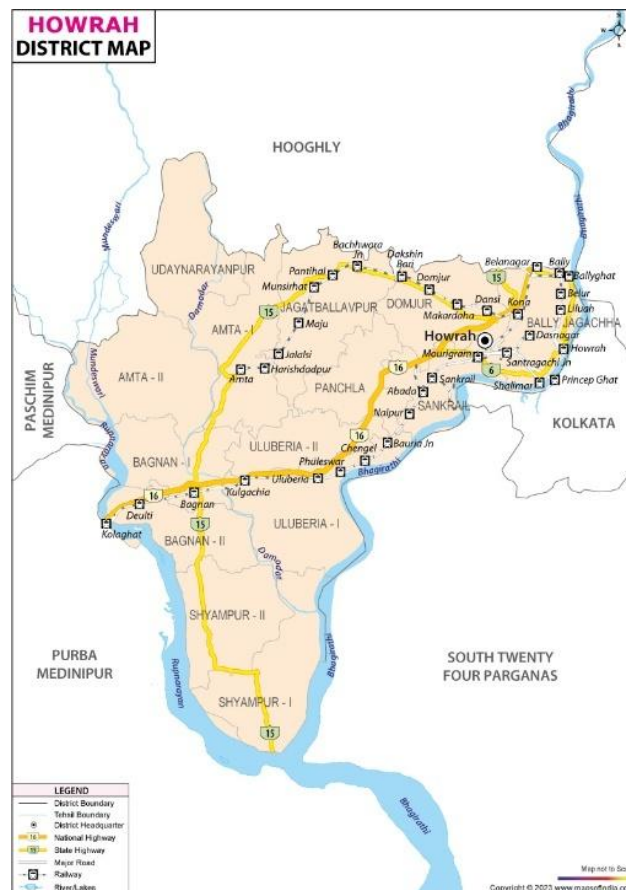

- **Children from economically weaker families in Howrah (West Bengal) and Village Mokimpur, Barh (Bihar), who lack access to quality education and learning resources.**
- **School-going children aged 6–16 years who require academic support through regular free coaching classes.**
- **Out-of-school and dropout children who need guidance, counselling, and assistance for re-enrollment in nearby formal schools.**
- **First-generation learners whose parents have limited education and cannot support their studies at home.**
- **Children with limited digital access, especially those in Howrah, who will benefit from free computer education and digital literacy sessions.**
- **Students lacking basic learning materials, who will receive stationery kits to support their academic needs.**
- **Families in the local communities, who will benefit indirectly through awareness, counselling, and school-admission support for their children.**

The project supported a total of 280 students belonging to economically weaker families. The initiative helped students continue their education through free coaching and academic support.

A. Free Coaching Classes (Howrah & Mokimpur, Barh)

- Daily academic support in subjects like Mathematics, Science, English, and Bengali/Hindi.
- Focus on concept clarity, homework support, and exam preparation.

B. Distribution of Stationery Items Each student will receive kits including:

- Notebooks
- Pencils and pens
- Erasers and sharpeners
- Geometry box
- Basic school supplies

C. Free Computer Classes (Howrah)

- Basic computer skills: typing, MS Office, internet usage.
- Digital awareness programs to prepare children for digital inclusion.

D. School Admission Assistance

- Identifying out-of-school children.
- Supporting parents with documentation and admission procedures.



- Ensuring children are enrolled in government or affordable private schools.

E. Community Awareness & Parent Interaction

- Regular meetings with parents to encourage consistent attendance and learning.
- Awareness sessions on child education, hygiene, and discipline.
- Engagement with local leaders and volunteers to strengthen community participation.

F. Progress Monitoring & Evaluation

- Daily attendance tracking of students.
- Monthly tests and progress reviews.
- Documentation of activities through photographs and reports.
- Final evaluation at the end of the project period (December 2025).

G. Volunteer & Teacher Engagement

- Seven teachers engaged (5 in Howrah, 2 in Barh).
- Orientation and training for better teaching techniques.

Regular coordination for lesson planning and reporting.

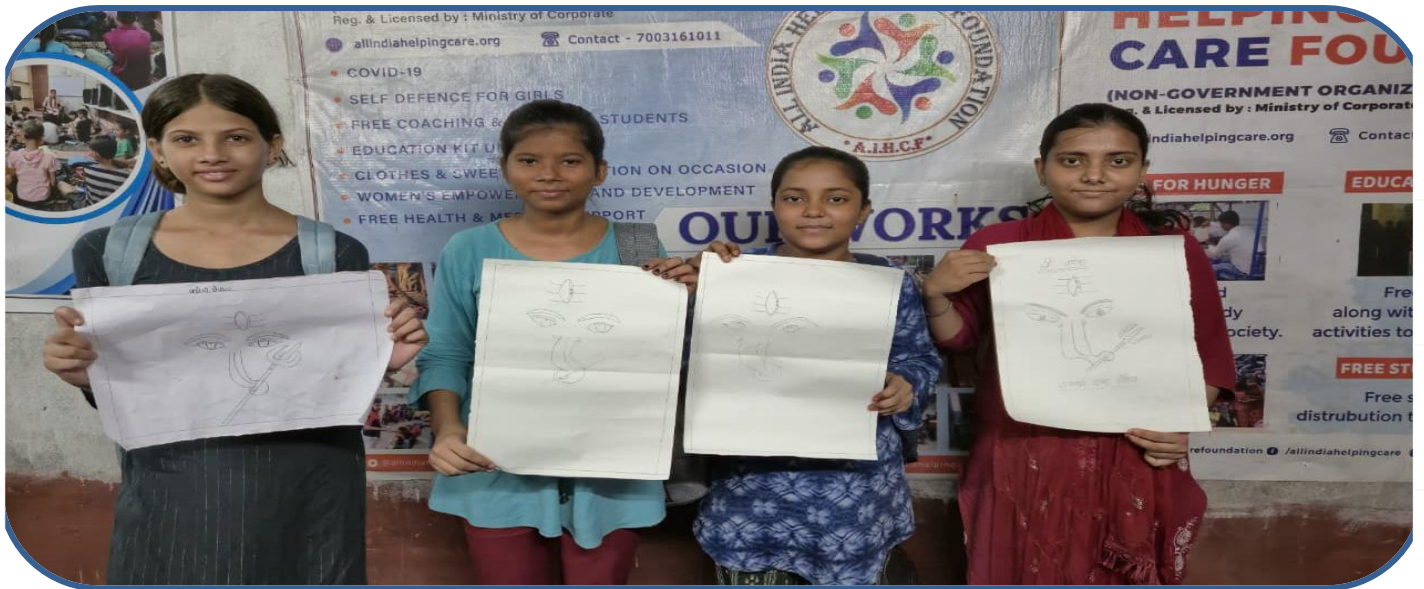
